If you have already joined NYSSA through another club you can claim exempt, while this does not save you anything it does the club as we pay your basic NYSSA Fee. MTR memberships includes: state registration voucher, decal and a min of 4 issues of Trail Notes, the MTR newsletter.

For the DMV voucher we need the EXACT names and address as it appears on ALL registrations. We have provided spaces for eight names, Member, Spouse (married or not) and up to six children, if there are any additional names required please include them on a separate piece of paper or on the back. Addresses must all be the same, which is what defines a family in the eyes of the voucher. We have provided for a separate mailing and voucher address if needed, if not leave voucher address blank. We only need last names if different from member.
